Contributions to the Georgia Republican Party, Inc. federal account are limited to \$10,000 per individual and \$5,000 per multi-candidate PAC per calendar year. Contributions from foreign nationals are prohibited. A copy of our report is available from the Federal Election Commission in Washington, DC and from the Georgia Campaign Finance Commission in Atlanta, Georgia. No federal officeholder, candidate or agent thereof is soliciting any contributions above the federal limit of \$3,000 per individual or \$5,000 per multi-candidate PAC or is soliciting funds from corporations, labor organizations or other federally-prohibited sources.
