Vendor Tables will be set up in the North Hall on the 1st Floor of the Convention Center. Your space will be a 10' wide x 6' deep. All Vendor must remain within the lines of their assigned vendor space. Each vendor table consists of a 8' foot skirted table, two chairs and a trash can. Hours of Operation: Friday, May 17th: 12:00 p.m. until 9:00 p.m. and Saturday, May 18th 9:00 a.m. until 8:00 p.m. Load-in and Set Up is on Friday, May 17th between 9:00 a.m. and 11:30 a.m.. Check-in will be at the loading dock. No food or beverages may be brought in or sold at vendor tables. You are permitted to bring small individually wrapped candy to place in a bowl or on your table. Any power needs will need to be set up through the convention center. There will be very limited space behind and in front of each table. If you require additional space, you may want to consider purchasing 2 vendor tables also.

*Federal law requires political committees to use our best efforts to report the name, mailing address, occupation, and name of employer for each individual whose contributions aggregate in excess of \$200.00 in a calendar year. State law requires political committees to report the name, mailing address, occupation and employer of any person making a contribution of more than \$100.00 in an election cycle.

Contributions to the Georgia Republican Party, Inc. are not deductible as charitable contributions for state or federal income tax purposes.

Individual contributions not exceeding federal limits will be deposited in the Georgia Republican Party, Inc. federal account. Corporate contributions will be deposited in the Georgia Republican Party, Inc. non-federal state account. Corporate contributions to the Georgia Republican Party, Inc. federal account are prohibited under federal law. Contributions to the Georgia Republican Party, Inc. federal account are limited to \$10,000 per individual and \$5,000 per multi-candidate PAC per calendar year. Contributions from foreign nationals are prohibited. A copy of our report is available from the Federal Election Commission in Washington, DC and from the Georgia Campaign Finance Commission in Atlanta, Georgia. No federal officeholder, candidate or agent thereof is soliciting any contributions above the federal limit of \$3,300 per individual or \$5,000 per multi-candidate PAC or is soliciting funds from corporations, labor organizations or other federally-prohibited sources.
